- *Government Gazette* 38925 dated 3 July 2015.

1. In terms of section 56 of the Customs and Excise Act, 1964, Part 1 of Schedule No. 2 is amended to the extent indicated below:

Anti-dumping duty items 211.06/5503.20/01.06 and 211.06/5503.20/02.06 are deleted, *with effect from 27 May 2015*, in order to terminate anti-dumping duties on staple polyester fibre as recommended in ITAC Report 496.

2. In terms of section 75 of the Customs and Excise Act, 1964, Part 1 of Schedule No. 3 is amended to the extent indicated below:

Rebate item 318.03/9028.30/01.06 is inserted to create a rebate provision for certain components used for the manufacture of electricity meters as recommended in ITAC Report 494.

3. Provisional payment relating to chips or french fries in terms of tariff heading 2004.10.20 falls away.
