1. In terms of section 56 of the Customs and Excise Act, 1964, Part 1 of Schedule No. 2 is amended, *with retrospective effect from 6 March 2015*, to the extent indicated below:

Anti-dumping duty items 215.02/8716.80.10/01.08, 215.02/8716.80.10/02.08 and 215.02/8716.80.10/03.08 are created for the imposition of anti-dumping on wheelbarrows originating in or imported from China as recommended in ITAC Report 502.

- 2. Editorial Correction: Please note that tariff subheading 315.05, appearing on page 783, should have appeared on page 782 in the correct sequence. This has now been rectified.

## **IMPORTANT NOTE:**

Please note that wheelbarrows, which are classifiable in Chapter 87 and which falls within Section XVII, should fall under anti-dumping duty item 217 and not under 215.02, as published above. The Jacobsens Team has brought this to the attention of the South African Revenue Services (SARS) and can confirm that this will be rectified by SARS in due course.
