This supplement contains amendments to the Jacobsens Harmonized Customs Tariff arising from amendments which were published in:

- *Government Gazette No. 41770* dated 13 July 2018;
- *Government Gazette No. 41798* dated 27 July 2018;
- *Government Gazette No. 41812* dated 3 August 2018;
- *Government Gazette No. 41818* dated 3 August 2018; and
- *Government Gazette No. 41828* dated 10 August 2018.

1. In terms of Section 48 of the Customs and Excise Act, 1964, Part 1 of Schedule No. 1 to the said Act is amended to the extent indicated in the note below:

The rates of duty on wheat and wheaten flour classifiable in tariff subheadings 1001.91 and 1001.99 as well as 1101.00.10 and 1101.00.90 are reduced from 43,72c/kg and 65,59c/kg to 28,17c/kg and 42,26c/kg respectively, in terms of the existing variable tariff formula as recommended in ITAC Minute 07/2018.

2. In terms of Section 75 of the Customs and Excise Act, 1964, Part 2 of Schedule No. 4 to the said Act is amended to the extent indicated in the note below:

Rebate item 460.03/0207.14.9/01.07 is amended to increase the annual quota for bone-in cuts for the species *Gallus Domesticus* (chicken), frozen, classifiable in tariff item 0207.14.9 imported from or originating in the United States of America as recommended in ITAC Minute 06/2018.

3. In terms of Section 48 of the Customs and Excise Act, 1964, Part 1 of Schedule No. 1 to the said Act is amended to the extent indicated in the note below:

The rate of duty on sugar of tariff subheadings 1701.12, 1701.13, 1701.14, 1701.91, and 1701.99 are increased from 233.81c/kg to 419.52c/kg due to the increase in the Dollar-Based Reference Price on sugar from US\$566/ton to US\$680/ton as recommended in ITAC Report No. 588.

4. In terms of Section 48 of the Customs and Excise Act, 1964, Part 1 of Schedule No. 1 to the said Act is amended to the extent indicated in the note below:

The rate of customs duty on ethylene-alpha-olefin copolymers having a specific gravity of less than 0.94 classifiable in tariff subheading 3901.40 is reduced from 10% to free as recommended in ITAC Report No. 584.

5. In terms of Section 75 of the Customs and Excise Act, 1964, Part 2 of Schedule No. 4 to the said Act is amended to the extent indicated in the note below:

Two rebate provisions (rebate items 460.15/7216.32/01.06 and 460.15/7216.33/01.06) are created for the importation of certain structural steel in the form of H and I sections classifiable in tariff subheadings 7216.32 and 7216.33 as recommended in ITAC Report No. 577.

6. In terms of Section 57A of the Customs and Excise Act, 1964, a provisional payment in relation to safeguard duty is imposed, **up to and including 18 February 2019**, on steel screws, fully threaded with hexagon heads, classifiable in tariff subheading 7318.15.39 as recommended in ITAC Report No. 589.

Notes regarding the amendments to the safeguard duties on hot-rolled steel products which were published on 10 August 2018

Background

According to the World Trade Organization, WTO members “may take a ‘safeguard’ action (i.e., **restrict imports of a product temporarily**) to protect a specific domestic industry from an increase in imports of any product which is causing, or which is threatening to cause, serious injury to the industry”.

In March 2016, the International Trade Administration Commission (ITAC) initiated an investigation into remedial action in the form of a safeguard against the increased import of certain hot-rolled products, following an application by the South African Iron and Steel Institute (SAISI) on behalf of the industry in the Southern African Customs Union (SACU).

In its final determination in ITAC Report No. 551, the Commission recommended that safeguard duties be imposed on certain flat hot-rolled steel products classifiable under heading 72.08 and subheadings 7211.19, 7225.30, 7225.40, 7225.91 and 7225.99 to take remedial action against a surge of imports on the products in question. The notices to implement the recommendation (Notices R. 829 to R. 831) were published in *Government Gazette* No. 41038 of 11 August 2017. Since safeguard duties are temporary measures, they must be phased out over a period of three years. Three notices were thus published to implement the existing rate of safeguard duty (initially 12% with effect from 11 August 2017), and to gradually reduced the rate of 12% to 10% and 8% respectively with effect from 11 August 2018, and then from 11 August 2019 until the expiry date of 10 August 2020.

Following the imposition of the safeguard duty, which is an additional customs duty, ITAC received an application for the creation of a temporary rebate provision on safeguard duty applicable to certain hot rolled steel products classifiable under certain tariff subheadings of headings 72.08 and 72.25, and following their investigation, recommended that the rebate provisions be created in the circumstances.

ITAC then decided to initiate its own investigation into the creation of rebate provisions on the ordinary customs duty and safeguard duties applicable to the products subject to the duties, with a view of creating rebate provisions for the subject products which are not manufactured in the Southern African Customs Union (SACU).

ITAC evaluated information received from various manufacturers and on the basis of the information received, recommended that temporary rebate provisions be created under item 460.15 for various products classifiable under the subheadings in question.

Reports 580, 582 and 583 were the latest reports that recommended the creation of such rebate provisions.

The following notices to give effect to the recommendations of these reports have been published on 10 August 2018.

Please see below:

7. In terms of Section 75 of the Customs and Excise Act, 1964, Part 2 of Schedule No. 4 to the said Act is amended to the extent indicated in the note below:
 - a) Various (temporary) rebate provisions have been created to exempt certain hot-rolled steel products (plate and coils), classifiable in tariff subheadings 7208.36, 7208.37, 7208.5 and 7225.40 from payment of ordinary customs duty and safeguard duties as recommended in ITAC **Report 583**.
 - *Government Gazette 41828*, R. 822, 10.08.2018 A4/2/389.
 - b) Rebate items 460.15/7208.25/01.06 and 460.15/7208.26/01.06 have been created on certain hot-rolled coils classifiable in tariff subheadings 7208.25 and 7208.26 as recommended in ITAC **Report 580**.
 - *Government Gazette 41828*, R. 814, 10.08.2018 A4/2/387
 - c) Various rebate provisions have been created for products subject to safeguard duty classifiable under tariff subheadings 7208.5, 7225.40 and 7225.99 as recommended in ITAC **Report 582**.
 - *Government Gazette 41828*, R. 818, 10.08.2018 A4/2/388

Schedule No. 2 was amended on 17 June 2016 by the insertion of rebate items listed in Schedule No. 3 and 4 in the column headed "Rebate Items" which will be subject to payment on the additional duties in Schedule 2 as recommended in ITAC Minute M10/2015. This recommendation was made to specifically provide for rebate provisions like the ones above to be excluded from payment of the duties in Schedule No. 2.

With effect from 17 June 2016, provisions in Schedule 2 had to be amended by the insertion of rebate provisions relating to these provisions.

Consequential to this measure, the individual safeguard duty provisions had to be amended to reflect the rebate provisions in question. Up to and including 10 August 2018 there were 3 safeguard duty provisions relating to the hot-rolled steel products, and every time a rebate provision was created each of these safeguard duty provisions had to be amended to reflect the rebate provision. For this reason, the following amendments under Part 3 of Schedule No. 2 were published. (NOTE THE EFFECTIVE DATES, AND KEEP IN MIND THAT THESE AMENDMENTS COINCIDED WITH THE ANNUAL REDUCTION OF THE SAFEGUARD DUTY FROM 12% TO 10%):

CHAPTER 11

PRODUCTS OF THE MILLING INDUSTRY; MALT; STARCHES; INULIN; WHEAT GLUTEN

Chapter Notes:

 - (a) a starch content (determined by the modified Ewers polarimetric method) exceeding that indicated in Column (2); and

Otherwise, they fall in heading 23.02. However, germ of cereals, whole, rolled, flaked or ground is always classified in heading 11.04.
 (B) Products falling in this Chapter under the above provisions shall be classified in heading 11.01 or 11.02 if the percentage passing through a woven metal wire cloth sieve with the aperture indicated in Column (4) or (5) is not less, by mass, than that shown against the cereal concerned.
Otherwise they fall in heading 11.03 or 11.04.
