This supplement contains amendments to the Jacobsens Harmonized Customs Tariff arising from amendments which were published in:

- *Government Gazette No. 41322 dated 15 December 2017; and*
- *Government Gazette No. 41327 dated 15 December 2017.*

1. In terms of Section 48 of the Customs and Excise Act, 1964, Part 1 of Schedule No. 1 to the said Act is amended to the extent indicated below:

The rate of customs duty on wheat and wheaten flour, classifiable in HS subheadings 1001.91, 1001.99, 1101.00.10 and 1101.00.90 is reduced from 91c/kg and 136.50c/kg to 71.63c/kg and 107.45c/kg respectively, in terms of the existing variable tariff formula as recommended in Minute 14/2017.

- *Government Gazette 41327, R. 1431, 15.12.2017 A1/1595*
2. In terms of Section 75 of the Customs and Excise Act, 1964, Section F of Part 1 of Schedule No. 6 to the said Act is amended, ***with retrospective effect from 30 September 2015***, to the extent indicated below:

Rebate item 623.14 is created to provide for a refund provision on distillate fuel for the manufacture of intermediate fuel oil.

3. In terms of Section 75 of the Customs and Excise Act, 1964, Part 3 of Schedule No. 6 to the said Act is amended, ***with retrospective effect from 30 September 2015***, to the extent indicated below:

Rebate item 670.03 is created to provide for Refund provisions on distillate fuel for the manufacture of intermediate fuel oil.

4. In terms of Section 48 of the Customs and Excise Act, 1964, Part 1 of Schedule No. 1 to the said Act is amended, ***with effect from 1 January 2018***, to the extent indicated below:

The rates of duty on certain fish products, classifiable in Chapter 3, and on certain textile products classifiable in Chapter 61, are reduced to implement the commitments of the Southern African Customs Union (SACU) in terms of the Economic Partnership Agreement between the European Union and the Southern African Development Community EPA States for 2018.

Separate 8-digit tariff subheadings have also been created in heading 39.19, subheading 2008.11 (peanut butter), 2103.99 (mayonnaise) and subheading 2809.20 (phosphoric acid and poly-phosphoric acids) to give effect to technical amendments.

### CHAPTER 3

#### FISH AND CRUSTACEANS, MOLLUSCS AND OTHER AQUATIC INVERTEBRATES

##### Chapter Notes:

## CHAPTER 11

### PRODUCTS OF THE MILLING INDUSTRY; MALT; STARCHES; INULIN; WHEAT GLUTEN

#### Chapter Notes:

1. This Chapter does not cover the following:
    - (a) Roasted malt put up as coffee substitutes (heading 09.01 or 21.01);
    - (b) Prepared flours, groats, meals or starches of heading 19.01;
    - (c) Corn flakes or other products of heading 19.04;
    - (d) Vegetables, prepared or preserved, of heading 20.01, 20.04 or 20.05;
    - (e) Pharmaceutical products (Chapter 30); or
    - (f) Starches having the character of perfumery, cosmetic or toilet preparations (Chapter 33).
  2. (A) Products from the milling of the cereals listed in the table below fall in this Chapter if they have, by mass on the dry product:
    - (a) a starch content (determined by the modified Ewers polarimetric method) exceeding that indicated in Column (2); and
    - (b) an ash content (after deduction of any added minerals) not exceeding that indicated in Column (3). Otherwise, they fall in heading 23.02. However, germ of cereals, whole, rolled, flaked or ground is always classified in heading 11.04.
  - (B) Products falling in this Chapter under the above provisions shall be classified in heading 11.01 or 11.02 if the percentage passing through a woven metal wire cloth sieve with the aperture indicated in Column (4) or (5) is not less, by mass, than that shown against the cereal concerned.
- Otherwise they fall in heading 11.03 or 11.04.
