This supplement contains amendments to the Jacobsens Harmonized Customs Tariff, arising as a result of the following amendments which were published in the following *Government Gazette*:

- *Government Gazette* 39300 dated 16 October 2015.

See below for more information:

1. In terms of section 75 of the Customs and Excise Act, 1964, Part 1 of Schedule No. 3 is amended to the extent indicated below:

Rebate items 320.01/5903.20.90/01.08 and 320.01/5907.00.90/01.08 are replaced by rebate items 320.01/5903.20.90/02.08 and 320.01/5907.00.90/02.08 in order to amend the wording of qualifying fabrics. According to SARS, the amendments implement the recommendations of ITAC Report 505. However, ITAC Report 505 relates to an increase in the rate of customs duty on zinc coated/galvanized steel, aluminium zinc coated steel and painted steel.

RAW HIDES AND SKINS, LEATHER, FURSKINS AND ARTICLES THEREOF; SADDLERY AND HARNESS; TRAVEL GOODS, HANDBAGS AND SIMILAR CONTAINERS; ARTICLES OF ANIMAL GUT (EXCLUDING SILK-WORM GUT)

CHAPTER 41
RAW HIDES AND SKINS (EXCLUDING FURSKINS) AND LEATHER

Chapter Notes:

1. This Chapter does not cover the following:
 - (a) Parings or similar waste, of raw hides or skins (heading 05.11);
 - (b) birdskins or parts of birdskins, with their feathers or down, of heading 05.05 or 67.01; or
 - (c) hides or skins, with the hair or wool on, raw, tanned or dressed (Chapter 43); the following are, however, to be classified in Chapter 41, namely, raw hides and skins with the hair or wool on, of bovine animals (including buffalo), of equine animals, of sheep or lambs (except Astrakhan, Broadtail, Caracul, Persian or similar lambs, Indian, Chinese, Mongolian or Tibetan lambs), of goats or kids (except Yemen, Mongolian or Tibetan goats and kids), of swine (including peccary), of chamois, of gazelle, of reindeer, of elk, or deer, of roebucks or of dogs.
2. (A) Headings 41.04 and 41.06 do not cover hides and skins which have undergone a tanning (including pre-tanning) process which is reversible (headings 41.01 to 41.03, as the case may be).
(B) For the purposes of headings 41.04 to 41.06, the term "crust" includes hides and skins that have been retanned, coloured or fat-liquored (stuffed) prior to drying.
3. Throughout this Schedule the expression "composition leather" means only substances of the kind referred to in heading 41.15.
