This supplement contains amendments to the Jacobsens Harmonized Customs Tariff arising as a result of the *taxation proposals* on excise products as tabled by the South African Minister of Finance in his Budget Review that was presented to the Parliament on 24 February 2016 at 14:47.

See below for more information:

- 1. Additional Note 3 in Chapter 22 in relation to the scope of beverages of subheading 2206.00.05 is amended;
- 2. Additional Note 6 in Chapter 22 in relation to the scope of tariff subheadings 2206.00.19 and 2206.00.21 is amended; and
- 3. A new additional note (Additional Note 7) has been inserted in Chapter 22. Additional Note 7 to Chapter 22 defines the term "brandy" for the purposes of tariff subheadings 2208.20.11 and 2208.20.91.
- 4. Tariff subheadings 2208.20.10 and 2208.20.90 are deleted and new tariff subheadings 2208.20.11 and 2208.20.91 are created to provide for "brandy" as defined in Additional Note 7 in Chapter 22.
- 5. Tariff Items 104.00 to 104.35.09 are substituted.
