- Binder 3: Schedule No. 10 pages 1375 to 2366; Customs and Excise Act 91 of 1964; International Trade Administration Act: Import Control and Export Control.
- 8. Once the updates for supplement 1080 have been filed, the updates received with supplement 1081 can then be filed following the normal procedure.
